



#### 1. Distinguishing Characteristics of the Social Work profession

This assignment is based on the information provided in chapter One of the required text book, "Introduction to Social Work" (Farley et at). (4) ask each team member to write a 200 word summary of their assigned reading and submit it as an individual assignment

(5) prepare a chronological timeline of 20 significant events in the history of social work and social welfare in the United States. The timeline needs to be prepared by the entire team, as a group, and to be submitted by the team leader.

#### 3. Web-based Assignment on Professional Organizations:

Google the web-sites for the following organizations: National Association of Social Workers (NASW), Council on Social Work Education (CSWE), Your state's Social Work Licensing body. Explore these web-sites and respond to the following questions:

- (1) What are the benefits of becoming members of NASW and CSWE?
- (2) What type of information can you find on each of these three websites (write a paragraph for each organization)?
- (3) What type of license will you become eligible for after receiving a Bachelor's degree in social work?
- (4) Which website provides information about the Social Work Code of Ethics? Please order a copy for yourself.
- (5) Find out when was the last time CSWE accredited the baccalaureate Social Work program at your university.

#### 4. Community Organization Assignment

To complete this assignment, read chapter Seven. Choose one case history from the three provided at the end of the chapter and respond to the following questions:

- (1) Identify the problem/need that needed to be addressed in this case history.
- (2) What steps were taken to address this problem/need?
- (3) If you were involved in this project, would you have used a different approach?
- (4) Why and what would you have done differently?
- (5) Can you identify some of the underlying principles of community organization in this case history?

#### 5. Role and Functions of professional social workers:

Visit a local social service agency that provides services in any of the following fields of practice: family and child welfare, addictions, health care, mental health, disabilities, services for older individuals, services for minority populations, and correctional services. Choose an agency that employs a professional social worker. Set up an appointment with the social worker for an interview and find responses to the following questions:

- (1) What are the services provided by the agency?
- (2) What are the various functions of the social worker in this agency?

- (3) What qualifications (including licenses) would be needed for a social worker to get employed by this agency?
- (4) How does this agency get funded?
- (5) What are the factors that would determine the salary-range of a social worker in this agency?

- (2) Summarize the various types of services that are provided to clients in that "field of practice."
- (3) Explain the role and functions of social workers in that "field of practice."
- (4) Give an example of a local agency that provides services in the "field of practice" selected by you for this assignment.

#### 7. Examinations:

In addition to doing the class assignments, students will be given three exams during the semester including the final exam. Each exam will cover one third of the course material and will be given as a "unit" exam.

## Chapter 1 What is Social Work?

#### CHAPTER SUMMARY

However fast-moving and uncertain today's world may be, people are still at its core. People have problems that invite professional assistance: personal, family, and community. Social welfare is an important aspect of the modern way of life. Social work is a profession that focuses particularly on helping people solve their personal, family, and community problems through enhancing social functioning. It emphasizes human values and the intrinsic worth of all people. The basic functions of social work are (1) restoration of impaired social functioning, (2) provision of social services, and (3) prevention. Social work shares some knowledge and skills with sociology, psychiatry, psychology, and counseling, but it possesses distinguishing characteristics that set it apart from these disciplines. Social work is moving ahead as a progressive profession in the helping services arena.

#### SUGGESTED DISCUSSION PROMPTS

- 1. Discuss some of the distinguishing characteristics that make social work a unique profession.
- 2. Discuss how social work is different from other human services professions such as sociology, psychology, counseling, and psychiatry.
- 3. Discuss why social work practice is considered an "art" with a scientific and value foundation.
- 4. Discuss the statement "social work practice values are not necessarily or altogether those universally or predominantly held or practiced in society."
- 5. Discuss how social workers "help clients help themselves."

#### SUGGESTED CHAPTER ACTIVITIES AND ASSIGNMENTS

- This is a type of "pretest" activity. On the first or second day of class, ask students to write down what they "think" (in their opinion) a "professional" social worker does or is expected to do in an agency setting. The goal of this assignment is to assess students' initial understanding of social work as a "profession."
- 2. Ask students to identify as many elements as possible in their "total" environment to help them understand how various factors have an impact on their lives. The goal of this activity is help students understand why social work emphasizes on the "total person" in the "total environment."
- 3. Ask students to identify any 5 personal strengths and 5 personal limitations (including personal values that they hold) that will help and hinder their professional social work career.
